A) REGISTRATION IN THE LEILOSOC® AUCTION PORTAL

1. The bidders must register in the LEILOSOC® website and insert all the necessary identification elements, such as name, address, citizen card or passport identification number and tax identification number;
2. The billing information should also be inserted;
3. The bidder takes responsibility for the accuracy and veracity of the inserted information;
4. After the registration is concluded, it will be necessary to confirm the email account given when creating your account. The validation of the registration is essential in order to be able to start bidding.

B) ABOUT THE ASSETS IN AUCTION

6.
